1. Congregation Or Tzion expects that there will be proper conduct from youth members at all time.
2. All people and event locations will be treated with kindness and respect. As defined by the Anti-Defamation League¹, bullying of any type will not be tolerated.
3. No bullying of any type will be tolerated.
4. For the safety of our Or Tzion Youth:
 - a. Participants may not leave programs early unless written permission is given to the Youth Director/Advisor from a parent or guardian.
 - b. Participants must inform a member of the staff when they leave an event.
 - c. Youth must stay inside the youth lounge or other event space during events, unless given explicit permission otherwise.
5. Any theft or other illegal conduct will be sufficient reason to be sent home and/or to place the offending youth group member(s) on probation within the Youth Department.
6. Possession or use of the following is not permitted: weapons; alcoholic beverages; illegal drugs; unauthorized prescription drugs; cigarettes; vaping paraphernalia; matches; lighters and incense or possession or using any other item deemed inappropriate or dangerous by Congregation Or Tzion staff. Possession of any of these items is grounds for dismissal from the youth program.
7. Congregation Or Tzion's interpretation of kashrut is to be observed at all times. Males must wear a Kippah/head covering whenever on the Or Tzion Campus and other locations (when appropriate). Female may do so if they wish.
8. Any additional rules pertinent to specific events shall be announced by the Youth Director/Advisor and shall be observed as written rules.
9. Each youth group member must have the signed Congregation Or Tzion Code of Conduct and Kadima/USY membership form on file at the Congregation Or Tzion office.

Any member breaking any of the above rules will be subject to disciplinary action, with the possibility of the member being removed from the program and sent home immediately, at his/her own expense, forfeiting all monies paid and may be asked not to return. Congregation Or Tzion has the right to cancel a participant's ability to be part of the youth group for any timeframe Or Tzion deems appropriate with a forfeiture of prior payments.

1. You must be a member to attend Kadima/USY events.
 - a. You may attend one (1) Lounge Night for free and attend one event at the non-member rate before joining. After that, you will need to become a member of Kadima/USY to continue attending events.
 - b. Annual dues must be paid in full prior to attending the second event.
 - c. You must be a paid member to attend regional events or run for the USY Board.
